DESCRIPTION

solution of non-ionic surfactants with rapid biodegradability and dirt disrupters. It does not contain caustic soda, ammonia, perfumes, dyes and solvents..

FIELDS OF APPLICATION

for ordinary cleaning of all stone surfaces as porcelain tiles, ceramic, klinker, stone, cotto, cement agglomerates.

CHARACTERISTICS

ECOMARBEC:

- biodegradable detergent over 98%;
- hypoallergenic product that does not contain caustic soda, ammonia, perfumes, dyes and solvents;
- cleans, degreases, sanitizes the surfaces in cotto, stone, cement, porcelain tiles and other ceramic materials;
- it acts by dissolving the fatty substances, making them easily removable;
- can be used for manual and mechanical washing (eg washer dryer, pressure washer).

INSTRUCTIONS FOR USE

it can be used pure or diluted in water.

Dosages:

- **Dilute 1 part of ECOMARBEC in 2 parts of water:** for heavily degreasing washes, to remove large amounts of greasy dirt (food / mineral oils, greases and stubborn dirt residues). Spread ECOMARBEC on the floor with a rag, mop and let it work for a few minutes, rub the surface with sponges or medium-hard pads, then rinse everything with clean water;
- **Dilute 180-250cc of ECOMARBEC in 5 liters of water:** for a periodic degreasing cleaning;
- **Dilute 50-100cc of ECOMARBEC in 5 liters of water:** for daily cleaning of all surfaces..

LIMITATIONS

- protect all the wooden surfaces from the contact with pure ECOMARBEC

PACKAGING

- 1 lt plastic tin – box 6 pc;
- 5 lt plastic tank – box 4 pc.
