STORAGE

Keep the product well closed at temperature between 0°C and +30°C.

The product if stored in this way has a shelf life of 2 years.

DESCRIPTION

Alkaline concentrated detergent solution based on inorganic salts. It does not contain strong alkali (caustic soda, ammonia). Low foaming.

FIELDS OF APPLICATION

Ideal to **clean all smooth microporous surfaces in stone** as **Porcelain tiles, Ceramic, Quarry tiles, Cement or Synthetic Agglomerates.**

CHARACTERISTICS

It eliminates fastly and deeply all the dirt, also the most stubborn, from low absorption and not absorbant materials where it is necessary to make a fast and easy domestic cleaning action.

- **It does not leave halos;**
- **it brings back the material to its original colour;**
- **the continuous use keeps joints clean;**
- **it avoids the necessity of frequent washes with aggressive acid detergents.**

INSTRUCTIONS FOR USE

- **GRES LINDO diluted 170-250ml (a glass) in 5lt of water:** for an extraordinary cleaning with degreasing agent or to eliminate traces or patinas of calcareous sinter left by the use of strong waters with domestic use. Spread the product on the surface with cloth, mop and let it dry some minutes, at the end rinse all with clean water.
- **GRES LINDO diluted 20-50ml (above one or half cup of coffee) in 5lt of water:** for the ordinary detergency of microporous surfaces in general.

LIMITATIONS

Do not use on surfaces treated with polymeric waxes. Do not use on materials that are not resistant to water and humidity (ex. Wood, paper).
