STORAGE

Keep the product well closed at temperatures between 0 ° C and + 30 ° C. The product thus conserved has a useful life of 2 years.

DESCRIPTION

O / A emulsion of waxes, resins, non-ionic surfactants.

FIELDS OF APPLICATION

Opaque ordinary maintenance wax for all oil-impregnated wooden surfaces with natural finish.

CHARACTERISTICS

Protective and maintenance wax for all oil-impregnated wooden surfaces with a natural opaque effect.

BIOCARE OPACO:

- **it preserves and protects over time the protective and aesthetic characteristics of the initial finish;**
- **it makes surfaces easier to clean and maintain;**
- **for internal use;**
- **it renews the superficial protection of the opaque treatment;**
- **does not form films;**
- **water-based product;**
- **does not leave bad smells in the rooms;**
- **does not release toxic or harmful components in the environments.**

INSTRUCTIONS FOR USE

Shake the product before use it. Apply the product in small quantities on a soft cloth and distribute a thin and even layer on the surface.

Do not step on the product during drying.

Frequency of use:

- **every 2-3 months:** *on surfaces heavily trampled and subject to heavy wear (eg shops, public places, bars, restaurants, kitchens, entrances, bathrooms, etc.);*
- **every 6-12 months:** *on poorly trampled surfaces (eg sleeping areas, rooms, etc.).*

LIMITATIONS

Do not use BIOCARE OPACO on painted woods. Avoid using strong alcohol detergents when cleaning surfaces treated with BIOCARE OPACO.
